

# Privacy Policy

## WHAT PERSONAL INFORMATION DOES MMCP ADVISORS REQUIRE?

1.1. MMCP Advisors's Personal Information Protection Policy governs the Processing of your Personal Information. 1.2. "Personal Information" is defined in the Protection of Personal Information Act (Act no. 4 of 2013) ("POPIA") as follows:

"Information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person, including, but not limited to –

- (a) information relating to the race, gender, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, wellbeing, disability, religion, conscience, belief, culture, language and birth of the person;
- (b) information relating to the education or the medical, financial, criminal, or the employment history of the person;
- (c) any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other particular assignments to the person;
- (d) the biometric information of the person;
- (e) the personal opinions, views or preferences of the person;
- (f) correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence;
- (g) the views or opinions of another individual about the person; and
- (h) the name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person."

1.3. "Processing" is defined in POPIA as follows:

"any operation or activity or any set of operations, whether or not by automatic means, concerning personal information, including—

- (a) the collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval, alteration, consultation or use;
- (b) dissemination through transmission, distribution or making available in any form; or
- (c) merging, linking, as well as restriction, degradation, erasure or destruction of information."

1.4. MMCP Advisors is a Responsible Party in respect of the Personal Information you (Data Subject) provide to the company. MMCP Advisors processes the following types of Personal Information from you:

1.4.1. Identification document

1.4.2. Proof of residential/business operating address;

1.4.3. 1.4.3.South African Income Tax registration number;

1.4.4. South African VAT registration number (if applicable per individual/legal entity); 1.4.5.Contact numbers;

1.4.5. Email addresses;

1.4.6. Banking details;

1.4.7. Any other information that may be requested from the Data Subject, if required.

## **2. WHY DOES MMCP ADVISORS REQUIRE YOUR PERSONAL INFORMATION?**

2.1. This Personal Information is required in terms of the Financial Intelligence Centre Act, 38 of 2001 and MMCP Fund Managers Risk Management and Compliance Programme. In addition, the Personal Information forms part of MMCP Advisors's requirements when obtaining a discretionary mandate from you or opening an account to facilitate the relevant business activities.

2.2. MMCP Advisors needs your Personal Information to provide you with the following services:

- To establish a legal relationship with you;
- To populate the client account information required on the various onboarding platforms to open your account; and
- To generate statements and capture contact information related to this discretionary mandate or account.

## **3. HOW IS YOUR PERSONAL INFORMATION PROCESSED?**

3.1. Your Personal Information is Processed at Co-work@Midstream, Midlands Office park west, Mount Quray Drive, Midstream Estates or any other branch of MMCP Advisors. Storage of your Personal Information takes place on a cloud- based server hosted by Microsoft.

3.2. No third-party providers have direct access to your Personal Information unless specifically required by law and to satisfy client due diligence principles.

3.3. Your Personal Information is shared with any contracted Product Supplier as listed in our Disclosure document for account opening purposes. The specific Product Supplier will be disclosed to the client before entering into a transaction.

**4. HOW LONG DOES MMCP ADVISORS KEEP YOUR PERSONAL INFORMATION?**

4.1. Under South African law, MMCP Advisors must keep your Personal Information for a five (5) year period following the date of termination of the business relationship according to MMCP Advisors' Personal Information Retention Policy. After this period, your Personal Information will be irreversibly destroyed. **5. WHAT ARE YOUR RIGHTS?**

5.1. Should you believe that any of your Personal Information held by MMCP Advisors is incorrect or incomplete, you have the right to request to view this information, rectify it or have it deleted. Please contact MMCP Advisors' Information Officer on [Nthabiseng Maudi](#) should this be required.

5.2. In addition, if you wish to complain about how MMCP Advisors has handled your Personal Information, please contact the Information Officer on [Nthabiseng Maudi](#) MMCP Advisors' Compliance Department will investigate your complaint and contact you within two (2) business days of the complaint being lodged and work with you to resolve the matter.
